LEGGETT & PLATT® PREMIUM BED FRAMES LIFETIME LIMITED WARRANTY

Leggett & Platt® Consumer Products Group (“LPCPG”) warrants to the original retail purchaser that Leggett & Platt Premium Bed Frames will at the time of purchase be free from defects in material and workmanship caused by LPCPG. This warranty shall apply during the original retail purchaser’s lifetime. “Premium Bed Frames” include, and are expressly limited to, the PRESTIGE®, THE EDGE™, INST-A-MATIC®, UNIMATIC® and HERITAGE™ bed frames.

This warranty extends only to the original retail purchaser and may not be assigned or transferred. An original retail purchaser is one who purchases the product directly from an authorized retailer. If purchaser is not the original retail purchaser of this product, he/she takes this product “as is” and “with all faults.” Proof of purchase will be required to demonstrate that purchaser is the original retail purchaser and eligible to make a valid claim under this warranty.

In the event of a defect during the warranty period, LPCPG’s sole obligation shall be to, at its option: repair, exchange, or allow credit for the product determined to be defective. To take advantage of this warranty, return the defective product to the store where purchased. If the seller has moved or gone out of business, contact LPCPG directly at either the website or the telephone number provided in the last paragraph of this warranty. Any transportation costs shall be borne by the purchaser.
